



2013 USA DIVING SUMMER JUNIOR ZONE CHAMPIONSHIPS

BID INFORMATION

EVENT OVERVIEW

The USA Diving Junior Zone Championships, annually held around mid-July, serve as qualifying competitions for the USA Diving Age Group National Championships and the Junior National Diving Championships. Approximately 250 divers participate in each event and there is competition on the 1-meter springboard, 3-meter springboard and 5-, 7.5- and 10-meter platform in four age groups – 11 and under, 12-13, 14-15 and 16-18. Divers qualify for these competitions through one of 10 junior region championships held throughout the U.S. The top 15 finishers in each event at the Region meets qualify for the following USA Diving Junior Zone Championships:

Regions 1 & 2: Zone A
Regions 3 & 4: Zone B
Regions 5 & 6: Zone C

Regions 7 & 8: Zone D
Regions 9 & 10: Zone E

BID PROCEDURE

Bids must be received by the USA Diving national office by **Monday, October 31st, 2011**. Bids must include a fully completed bid application, photographs of the venue inside and outside and a letter of intent agreeing to comply with all bid requirements. **Please mail bids to: USA Diving, 132 E. Washington St., Suite 850, Indianapolis, IN 46204. The Site Selection Committee is responsible for selecting the sites for these meets with the USA Diving national office.**

BID REQUIREMENTS

A. USA Diving requires:

- Facility with 2 one-meter and 2 three-meter springboards, 5-, 7.5- and 10-meter platforms.
- Host an opening ceremony/reception for all participants

B. Local Organizing Committee retains:

- \$20 entry fee, percentage of late fees

- Exhibits*
- Program advertising and sales

C. Restrictions:

- No conflicting corporate involvement with USAD sponsors (includes venue and off-site promotion and advertising).
- No rights to license meet name or logo. (This does not preclude LOC from producing and selling event souvenir merchandise with written consent from USAD)
- USAD official swimwear sponsor retains the right to designate an exclusive vendor for the meet.
